Re: *Index to Letters for Bodies of Elders*

Dear Brothers:

Along with this letter, we are providing a revised *Index to Letters for Bodies of Elders* (S-22). The January 2012 version of the index should be removed from the congregation file and be destroyed. See the letter dated September 7, 2011, for additional instructions regarding the index and the congregation permanent file of policy letters.

Henceforth, a revised *Index to Letters* will be posted on jw.org each time a letter is added to or removed from the congregation permanent file of policy letters. We leave it up to the judgment of each elder and congregation secretary whether to print out the revised index or simply update his personal or congregation copy.
